The Dark Sky Private Plan Change



A private plan is being prepared by the Kaikōura Dark Sky Trust to help Kaikōura become an International Dark Sky Sanctuary.

We have engagement Kāhu Environmental as planning consultants to assist us with the process.

Why is a Plan Change Required



- Light pollution is the biggest problem for an International Dark Sky Sanctuary.
- To qualify for the dark sky Sanctuary, we need to ensure that lighting is managed in the district to reduce light pollution and protect our dark sky.
- The operative district plan provisions manage lighting, but only so far as to manage effects on amenity and nuisance (maximum lux level at the property boundary)
- The current district plan provisions do not address light pollution that affects the brightness and clarity of the night sky.
- The current provisions do not meet the International Dark Sky Association requirements for dark sky sanctuary certification.

Dark Sky Sanctuary Requirements



International Dark Sky Sanctuary requirements:

- Lighting regulation binding on all public and private landowners in area of protection.
- Recognition of the dark sky as an important natural feature of the district in an official document.
- Management of outdoor lighting, requiring:
 All lights to be shielding and directed down
- All lights to have a restricting colour temperature of lighting to 3000k or less
- (Possible exceptions to some rules for lights on a sensor/timer for less than 5 minutes)
- Controls on illuminated signs
- Controls on sports lighting.

Anticipated Changes to District Plan



We are currently in the process of drafting provisions and will review these with the Councils planning team prior to submission of the plan change to Council before the end of July.

The plan change will:

- Recognise the importance of the night sky as a natural value of our district that warrants protection.
- Ensure that any outdoor lighting is shielded do that light goes out and down not out and up!
- Require to makes sure the 'colour temperature' of new outdoor lighting is 3000 Kelvin and under
- Provide exemptions if outdoor lighting is on a five-minute (or less) sensor/timer.
- Provide some rules that limit illuminated signage
- Provide some rules that limit hours of operation for sports lighting

Helping Kaikoura become a Dark Sky Sanctuary

The Kaikoura Dark Sky Trust (Trust) is about to apply to the International Dark Sky Association (IDD) to certify the Kaikoura District as an International Dark Sky Sanctuary (IDSS) which will bring environmental, social, economic and cultural benefits to the people in our district.

lanaging light pollution better will help us become a Dark Sky Sanctuary

Light pollution is the biggest problem for an International Dark Sky Sanctuary and in order to reduce it and protect our night sky we need to make sure outdoor lighting is 'managed' in the district.

Why is a change to the District Plan required?

The Kaikbura District Plan is a public document that guides how we manage activities and environmental impacts (like outdoor lighting) in our district. District plans are reviewed approximately every ten years, but councils or individuals/groups can initiate 'plan changes' between the major reviews. This helps keep the plan current and respond to opportunities like the dark sky certification.

The current district plan provisions do not address light pollution that affects the brightness and clarity of the night sky. The current provision

The Trust would therefore like to add and change some objectives, policies, and rules (collectively called 'provisions') in the Kaikoura District Pla so light pollution can be managed better.

What changes will be proposed?

To meet the IDA requirements for an IDSS, we need provisions in the district plan to:

- Recognise the natural value of the night sky is important to our district and needs protection.
- Ensure that any outdoor lighting is shielded so light goes out and down, not out and up!
- Make sure the 'colour temperature' of new outdoor lighting is 3000.

 Kelvin and under (warm not cold).
- Introduce some rules that manage illuminated signage.

There will be exemptions to the above if the outdoor lighting is on a sensor/timer of five-minutes or less.

It is important to note that any new provisions would not apply to existing lighting. If you add to your lighting, then the new provisions would apply.

However, people are encouraged to change their lighting to meet these new standards and help reduce light pollution in the district.

What is the change process

The Trust is currently in the process of preparing a private plan change. This work will include:

- the changes that we need to make to the district plan to become a dark sky sanctuary, and
- a report (932 of the RMA) that explains the reasoning behind the proposed changes and considers costs and benefits.

Once ready, the Trust will submit the plan change to Kaikoura.

This plan change will be publicly notified and anyone can make a submission on it.

The submissions will be considered at a hearing by a hearing panet (chosen by the Council), who will issue a decision on the plan change. If parties disagreewith the decision an option exists to appeal to the Environment Court.
