Environment Canterbury wishes to ensure that the Kaikōura community is resilient and well-placed for natural hazards including tsunami. As part of this work modelling has identified that much of the Canterbury Coastline including Kaikōura could be subject to Tsunami inundation. The modelling has led to the recommendation of evacuation zones, these zones are not within the current planning framework and are suggested for civil defence purposes, providing evacuation information is likely to result in other planning questions.
