## 1. SUMMARY

The role of the District Licensing Committee (DLC) is to consider and decide on all applications for alcohol licenses within the District in accordance with The Sale and Supply of Alcohol Act 2012 (the Act).

Council can appoint a commissioner and/or a community member to the DLC for a fixed term of up to five years and can be reappointed for one or more further periods of up to five years. The Act requires a commissioner to be of good standing in the community and someone who has the necessary knowledge, skills, and experience relating to matters that are likely to come before a committee. A commissioner has all the functions, powers and duties of the Chair and can be appointed as a Chair of the DLC for hearings.

The Act states that the following persons cannot be appointed as a commissioner: a police officer, Medical Officer of Health, an alcohol licensing inspector, or an employee of the Council.

#### 2. BACKGROUND

Sue Griffin was appointed as a Commissioner of the DLC (effective from 24 March 2021). Sue has indicated that she will be resigning from her role as Commissioner and community member of the DLC once a suitable replacement is appointed. It is the opinion of staff and the DLC Chair that an independent commissioner is still required on the DLC for times where there is a conflict of interest or the case is complex in nature and requires additional experience.

The Chair of the DLC recommends that Council consider appointing Merelyn Redstone as an independent commissioner. Merelyn Redstone is not considered an excluded person, has the desirable knowledge, skill set and experience in running hearings and leading decision-making processes in line with the Act. The CEO has followed up with references provided.
